- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

To make your election, please mark "X" in the appropriate box in the enclosed reply form (with postage pre-paid mailing label at the bottom of the reply form<sup>#</sup>) and sign and return the same to the Company's Hong Kong Share Registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong.

If you select the Website Version, please provide your email address and you will receive the Notification by email.

## If the Company does not receive the enclosed reply form or receive an objection from you by 20 March 2012, you will be deemed to have consented to receiving the Website Version for all the Corporate Communications and only a Notification will be sent to you in the future.

Even if you elect the Website Version, you have the rights at any time to change your choice of language and means of receipt by sending reasonable prior notice in writing to the Company's Hong Kong Share Registrar. You may also send such notice by e-mail to antonoil@computershare.com.hk. If you have difficulties in receiving or gaining access to the Website Version of the Corporate Communications, the Company will upon your request in writing or by email send the printed versions of the Corporate Communications to you free of charge as soon as possible.

Please note that the Website Version of both English and Chinese languages of the Corporate Communications will be available on the Company's website at www.antonoil.com and on the website of The Stock Exchange of Hong Kong Limited at www.hkexnews.hk.
