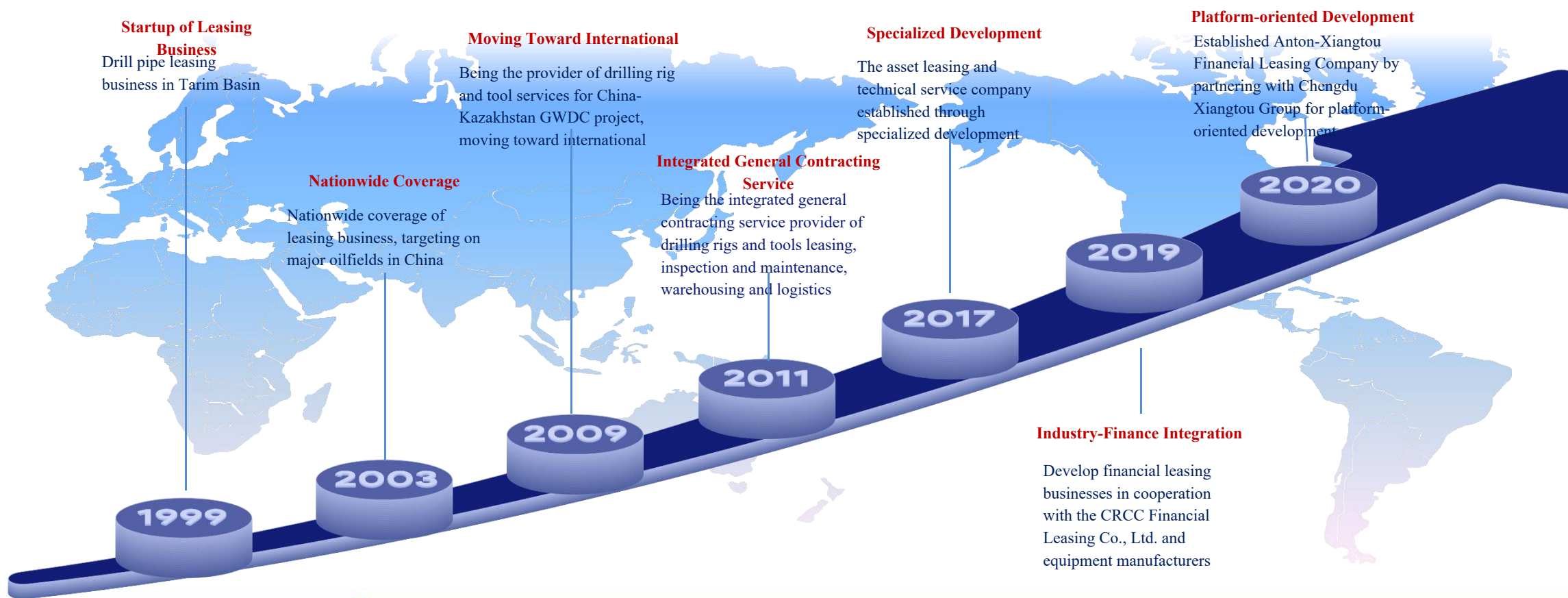

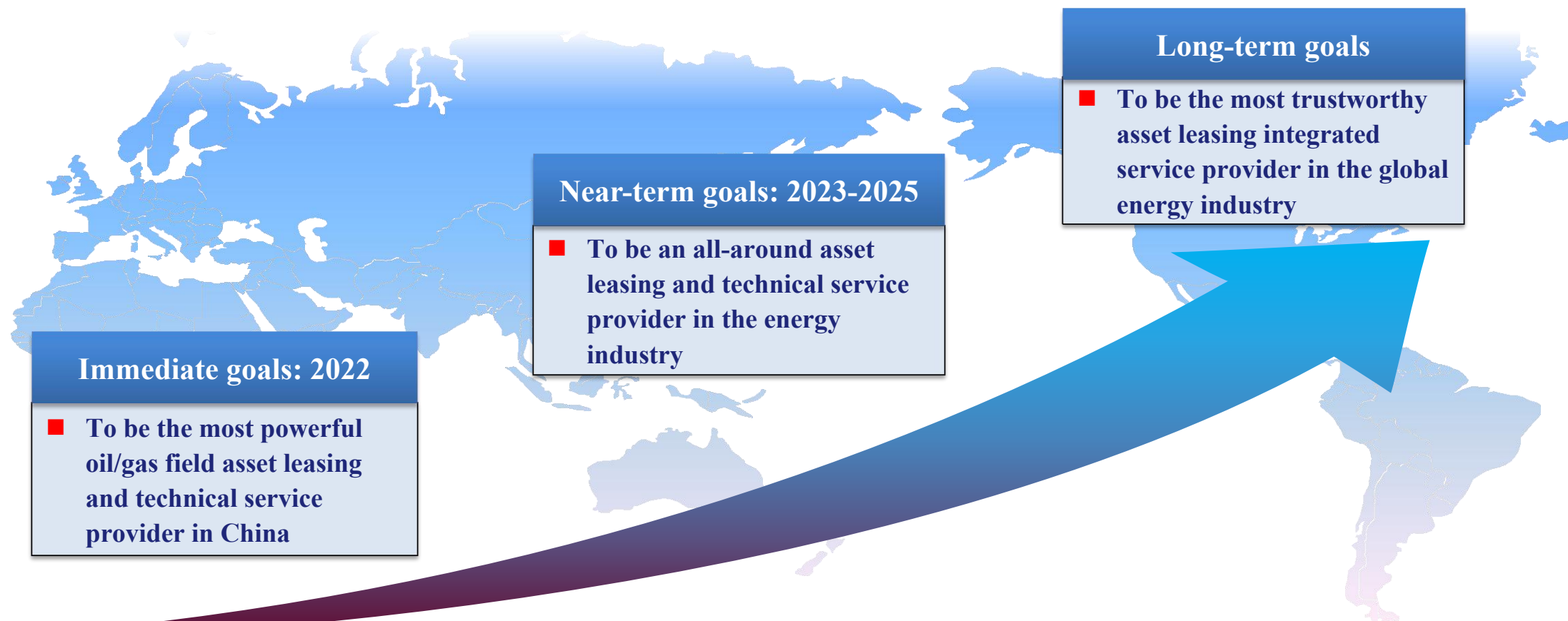
- ❑ In 1999, the company launched drilling tool leasing business, and it is the **first professional** company to provide drilling tool leasing services in China

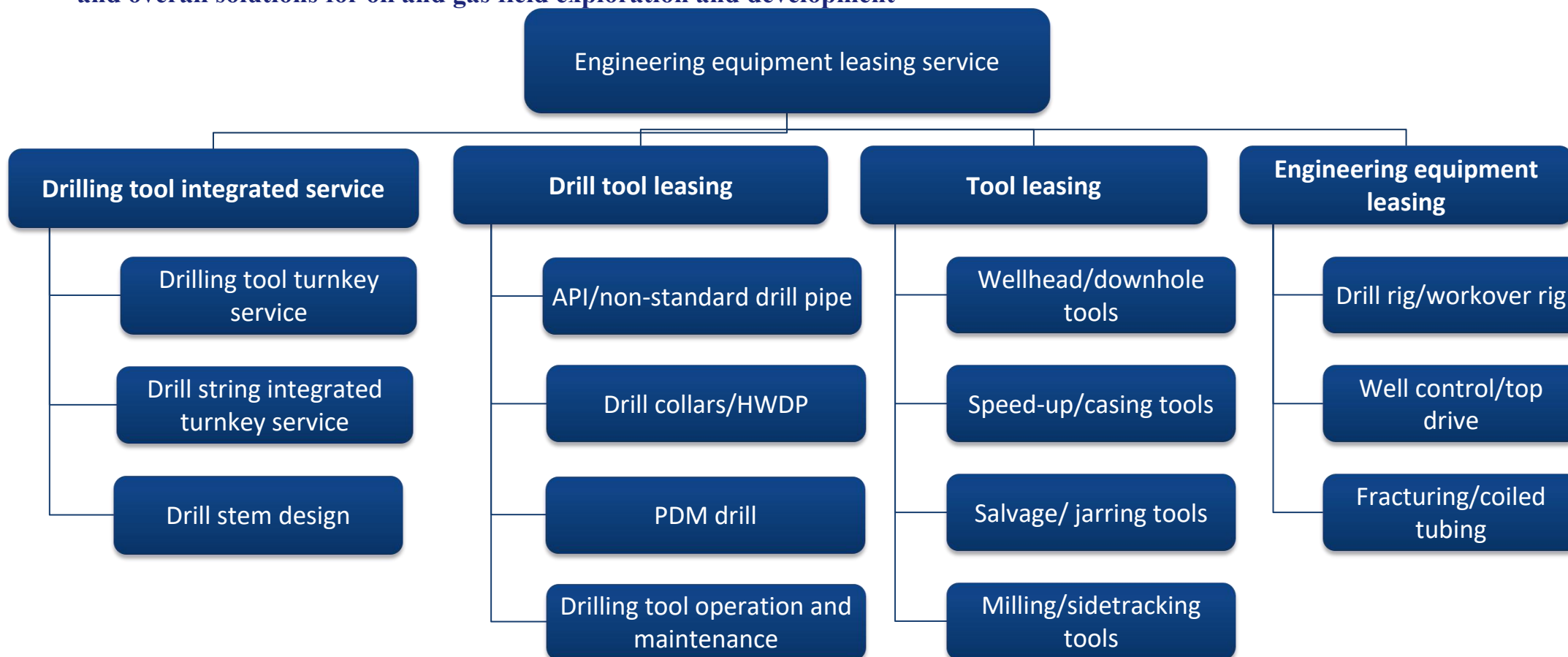


- Anton Asset Leasing covers three major sectors: **engineering equipment leasing services, oilfield production equipment and facilities leasing services, and asset management services**
- The business scope ranges from the whole process of oil and gas field exploration and development and surface engineering to new energy construction and application, etc.

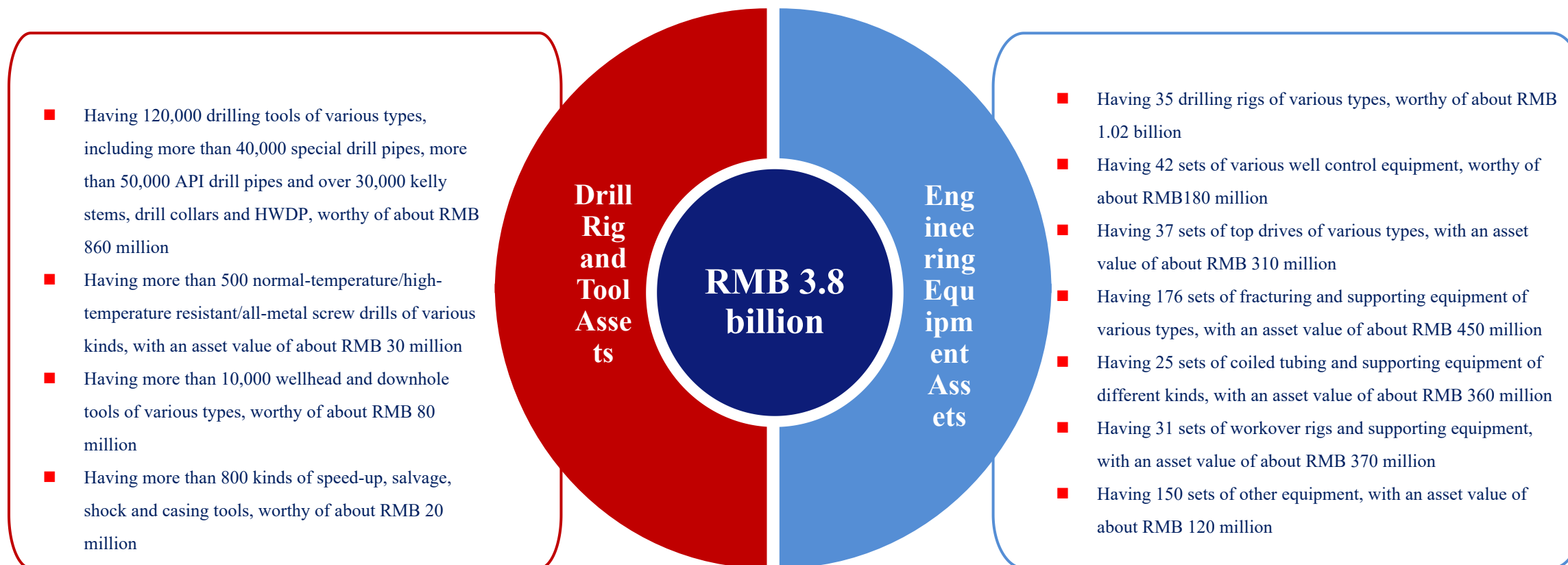


- It leverages diversified cooperative modes and platform-based ecological development to boost the asset-light development of customers through the integration of industry and finance

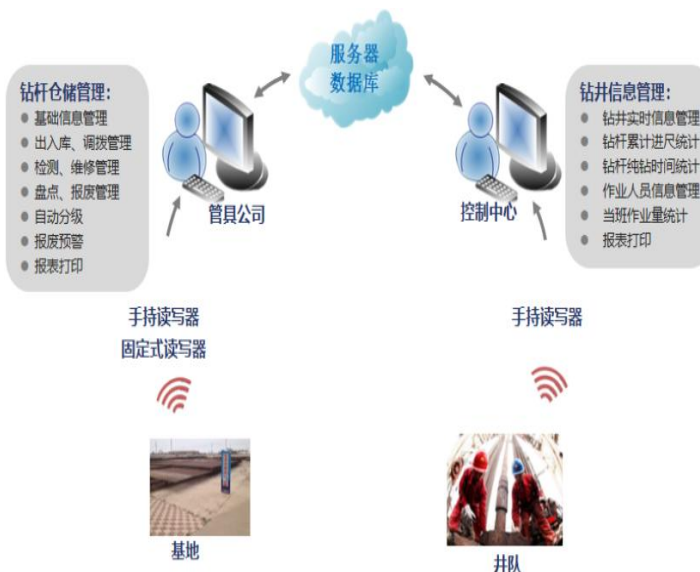
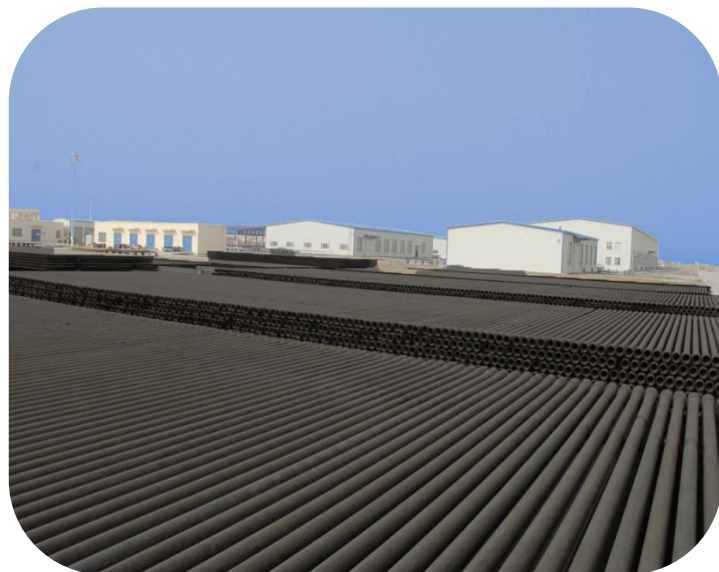
□ Drilling tool integrated service

- Supported by professional team of drilling experts and engineers to determine the optimal drilling tool assembly and tool selection design according to different formation conditions
- Provide integrated general contracting services for the entire drill string from drill bit to kelly stem, to solve the problem of thread type mismatch and difficulty in model selection.



□ Drill tool leasing

- Owing to our strong drilling tool resource assurance and industrial resource coordination capabilities, we can allocate different drilling tool resources according to different types of operations
- With rich experiences in drilling tool leasing management, information technology has been applied to drilling tool leasing services to realize full life cycle management of drilling tools
- Supporting operation and maintenance bases and on-site well inspection engineers to guide the use of drilling tools to address on-site problems and ensure safety in use
- Various types of non-standard ($2\frac{7}{8}''-5\frac{7}{8}''$), high steel grade (V150), and high torsional drilling tools are available to meeting various performance requirements of deep and ultra-deep well operations



□ Tool leasing

- From conventional wellhead and downhole tools to various emergency tools for drilling and workover incidents, we are able to meet all demands for tools required at each construction step
- Leasing service is also available for more than 10 kinds of tools, such as ground torsional pendulum equipment, swirl sand cleaner, multiple activation bypass valves, and micro reaming tools.
- By integrating the professional salvage tool service capabilities, we design and manufacture tools according to customer needs and provide matching salvage tools and service solutions



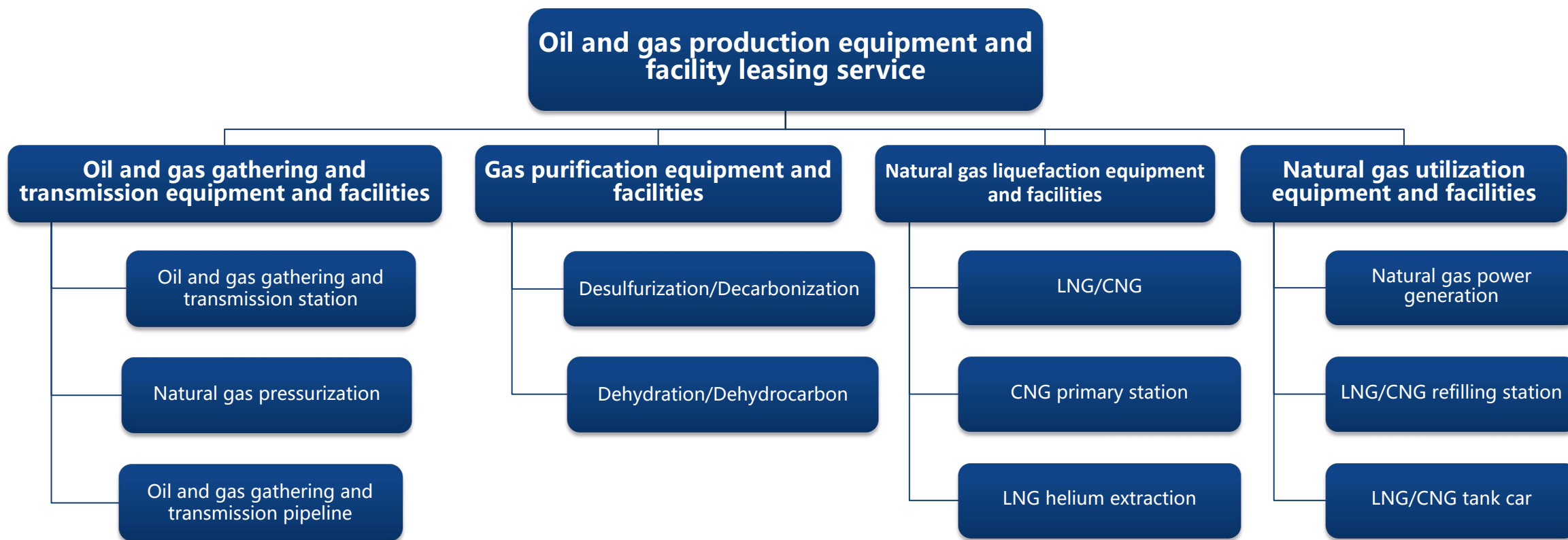
□ Engineering equipment leasing

- ❑ Construction and operation of oil and gas gathering and transmission, natural gas purification, LNG and CNG plants (stations)
 - Relevant engineering design, HAZOP/SILL analysis, project pre-evaluation, general contracting of engineering construction, engineering supervision, and equipment supervision and commissioning
 - Production and operation & maintenance management of oil and gas gathering and transmission station, gathering and transmission pipeline, booster station, natural gas purification plant, LNG plant, and LNG/CNG refilling stations

- Leasing of oil and gas gathering and transmission equipment and pressure boosting equipment and facilities
 - Oil and gas gathering and transmission: related engineering design, and leasing of oil and gas gathering and transmission equipment (separator, heater, receiver and launcher, desander, vent delivery flask, heat exchanger, gas condensate stabilizer, filter, metering device, etc.)
 - Natural gas pressurization: related engineering design, and leasing of supercharging equipment (reciprocating compressor, screw compressor, and mixed transportation sucking pump) at well site and in gas gathering station

❑ Leasing of gas purification equipment and facilities

- Natural gas desulfurization/decarburization: related engineering design; and leasing of MDEA desulfurization and decarbonization unit; decarbonization unit by membrane separation method; and desulfurization unit by dry method
- Natural gas dehydration/dehydrocarbon: related engineering design; and leasing of TEG dehydration unit; PSA (pressure swing adsorption) device; propane refrigeration dehydration and dehydrocarbon unit; ethylene glycol regeneration unit; and heat supply equipment of thermal oil furnace

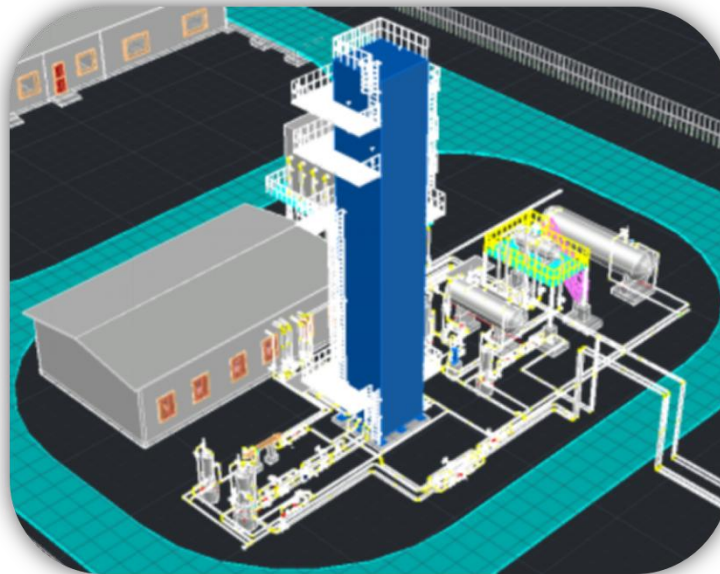

❑ Leasing of natural gas liquefaction equipment and facilities

- LNG skid-mounted equipment: leasing of 30,000-200,000m³/d LNG skid-mounted equipment (purification equipment, refrigeration equipment, cold box, etc.)
- LNG helium extraction: leasing of helium extraction technology unit from LNG flash vapor by membrane separation technology
- CNG primary station: leasing of natural gas dehydration and drying unit, metering skid and high-pressure compressor
- Engineering design: assist process optimization, 3D-design software accurate matching, unit modularization, skid-mounted unit, and digital delivery

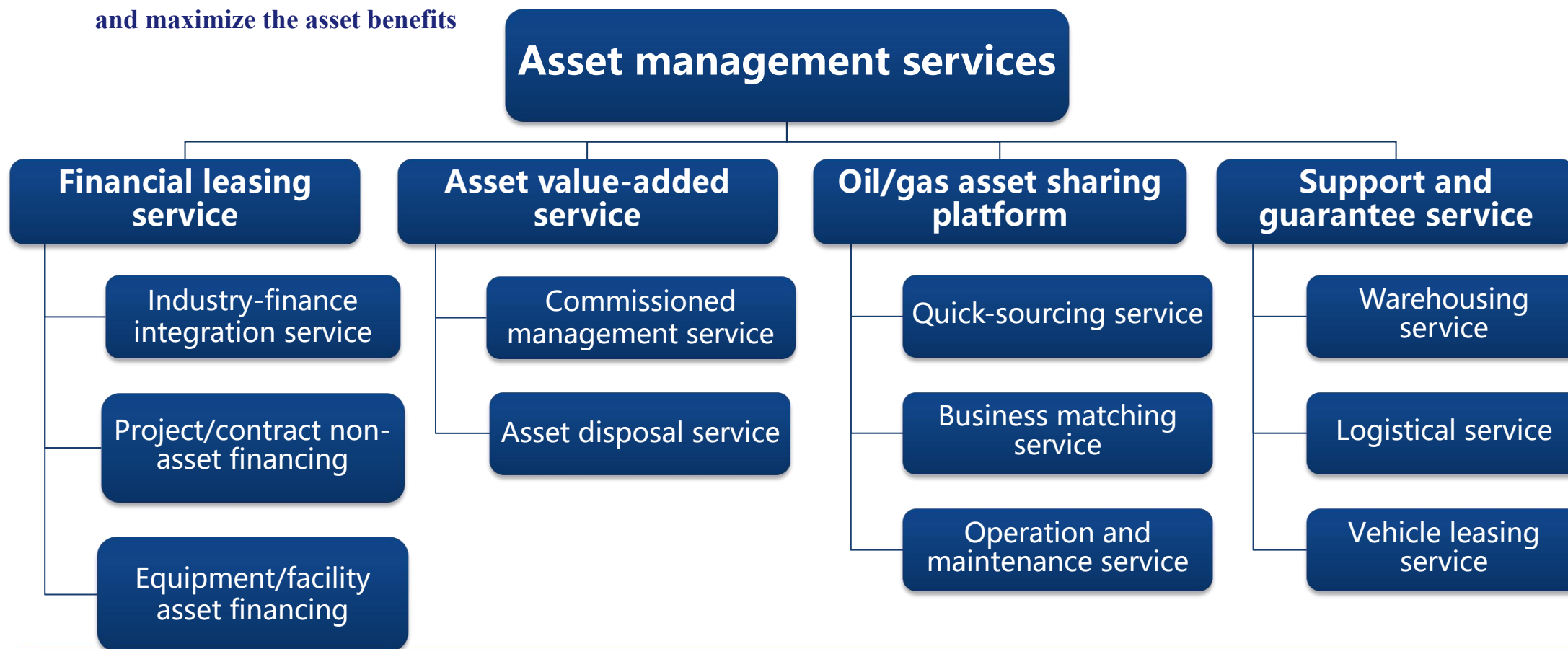

- Natural gas generator set: leasing of gas generator and LNG generator
- Leasing of LNG/CNG tank car

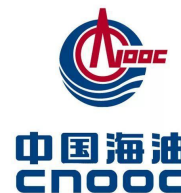

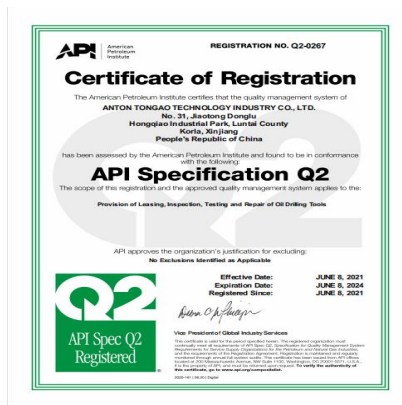
